RESOLUTION AUTHORIZING THE FILLING OF APPLICATIONS WITH THE FEDERAL TRANSIT ADMINISTRATION, AN OPERATING ADMINISTRATION OF THE UNITED STATES DEPARTMENT OF TRANSPORTATION, FOR FEDERAL TRANSPORTATION ASSISTANCE AUTHORIZED BY 49 U.S.C. CHAPTER 53, AND FOR ANY TITLE 23 UNITED STATES CODE AND OTHER FEDERAL STATUTES ADMINISTERED BY THE FEDERAL TRANSIT ADMINISTRATION.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE NORTHWEST ARKANSAS REGIONAL PLANNING COMMISSION:

SECTION 1. The Executive Director or his designee is authorized to file and execute an application for Federal assistance on behalf of the Northwest Arkansas Regional Planning Commission with the Federal Transit Administration for Federal assistance authorized by 49 U.S.C Chapter 53, Title 23 United States Code or other Federal statutes authorizing a project administered by the Federal Transit Administration.

SECTION 2. The Executive Director or his designee is authorized to execute and file with its application(s) the annual certifications and assurances and other documents the Federal Transit Administration requires before awarding a Federal assistance grant or cooperative agreement.

SECTION 3. The Executive Director or his designee is authorized to execute grant and cooperative agreements with the Federal Transit Administration on behalf of the Northwest Arkansas Regional Planning Commission.
