# A RESOLUTION AMENDING THE NORTHWEST ARKANSAS REGIONAL TRANSPORTATION STUDY (NARTS) FY 2024 UNIFIED PLANNING WORK PROGRAM (UPWP) TO INCLUDE VARIOUS PLANS AND STUDIES

**WHEREAS,** U.S. Department of Transportation regulations require an areawide multi-modal transportation plan and a continuing planning process for urbanized areas; and

WHEREAS, said mandated planning process, known as the "3C" (Continuing, Cooperative and Comprehensive) planning process, must be carried out by a designated Metropolitan Planning Organization (MPO), and is necessary for transportation projects to qualify for federal transportation funds; and

**WHEREAS,** the Northwest Arkansas Regional Planning Commission (NWARPC) is the designated MPO for the Fayetteville-Springdale-Rogers, AR-MO Urbanized Area; and

WHEREAS, transportation planning to be undertaken by and under the direction of the MPO must be contained in an approved Unified Planning Work Program (UPWP); and

WHEREAS, Resolution #2023-04 authorized NWARPC to file application for the Federal Transit Administration (FTA) Areas of Persistent Poverty (AoPP) Grant and administer the grant should it be awarded: and

WHEREAS, the NWARPC was awarded \$180,000 AoPP Grant by the FTA (90% federal) with the \$20,000 local match (10%) being split by Ozark Regional Transit (ORT) and Razorback Transit; and

WHEREAS, Resolution #2023-15 authorized NWARPC to utilize \$440,000 suballocated Environment Protection Agency (EPA) Climate Pollution Reduction Grant (CPRG) Planning funds to conduct regional Energy and Environment Innovation Action Planning; and

**WHEREAS,** the NWARPC wishes to include the above mentioned projects in the FY 2024 UPWP along with other local and state studies for which NWARPC will provide assistance as needed.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE NORTHWEST ARKANSAS REGIONAL PLANNING COMMISSION:

That the Northwest Arkansas Regional Planning Transportation Study (NARTS) FY 2024 Unified Planning Work Program (UPWP) is hereby amended to reflect additional work projects and studies being undertaken in the fiscal year as shown in Exhibit A, which is attached hereto.

- 2. Recommend continued and expanded route testing with NWA businesses and municipalities.
- 3. Assist the transit agencies with route planning and scheduling through appropriate software acquisition \$19,800 (\$15,840 per year Federal and \$3,960 Local Match-split equally between ORT, Razorback, and NWARPC).
- 4. Continue to coordinate and support ARDOT, ORT and Razorback Transit in implementation of their public transportation agency safety plans (PTASP).

- 5. Approval by the NWARPC/Policy Committee of the PTASP, at least within 180 days after the date of transit agency approval. The NWARPC/Policy Committee approved Resolution #2020-12 on December 2, 2020, in support of ORT's and Razorback Transit's PTASP(s).
- 6. If awarded, mManage and support the FTA Areas of Persistent Poverty (AoPP) Grant Enhancing Equitable Transit Connections in NWABus Stop Enhancement Plan Implementation project.
