(1) CALL TO ORDER

The in-person and virtual NWARPC Technical Advisory Committee (TAC) Meeting was called to order by Chair Patsy Christie at 10:33 a.m.

(2) ROLL CALL OF MEMBERS

In-person attendees named themselves, with Tim Conklin naming the virtual attendees. Nicole Gibbs recorded member names and tallied votes. A quorum was reached.

(3) APPROVAL OF THE JULY 18, 2024 TAC MEETING MINUTES

Chair Patsy Christie presented the item and hearing no comments, requested a motion to approve the TAC meeting minutes from July 18, 2024.

MOTION: Paul Libertini made a motion to approve the July 18, 2024 Meeting Minutes. The motion was seconded by Chris Brackett. Motion passed unanimously.

(4) NARTS FFY 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) – Recommendation to the RPC/Policy Committee

Chair Patsy Christie introduced the item and Tim Conklin provided background on the proposed Transportation Improvement Program (TIP) before summarizing notable regional projects featured in the four-year program. He said the most notable projects within this TIP include: Highway 612 Springdale Bypass, I-49 J Street Interchange, and Highway 112 improvement projects. He said ARDOT has shown the 612 Bypass as being funded in 2025 in the past but the TIP now shows the project as funded in 2028. He said he was told by ARDOT staff the project can still be funded whenever it is ready to be bid. Conklin also reminded attendees of the Highway 112 Regional Vision, championed and adopted by the commission, which outlines a higher caliber design for the highway desired by corridor communities. He said the design shown in the regional vision includes roundabouts, access management, sidewalks and a shared use path, all features that improve traffic flow while maintaining a high level of safety for all road users. Lastly, Conklin mentioned that Lowell Mayor, Chris Moore, requested that Highway 264 improvements from Bellview to Goad Springs Rd, be added to the 2025-2028 TIP. He stated that the STBGP-A Selection Committee chose to award \$506k to the Hwy 264 project contingent ARDOT agreeing to partner with the city to carry out and fund future phases of the project and to program the project in the Statewide Transportation Improvement Program (STIP). He said the project in question has not yet been included in the STIP.

Chair Patsy Christie asked if there were any questions or comments on the item and hearing none requested a motion recommending the NARTS FFY 2025-2028 Transportation Improvement Program (TIP) to the RPC/Policy Committee for approval.

MOTION: Paul Libertini made a motion to recommend the NARTS FFY 2025-2028 Transportation Improvement Program (TIP) to the RPC/Policy Committee for approval. The motion was seconded by Melissa McCarville. Motion passed with one vote opposing the motion.

(5) NARTS MS4 STORMWATER COMPLIANCE PERMIT UPDATE – Presentation by Katie Teague, Washington County Extension

Chair Patsy Christie introduced the item and Tim Conklin provided a summary of the past work done by the University of Arkansas Division of Agriculture’s Cooperative Extension Service (UACES). Conklin then introduced Katie Teague, County Extension Agent for Washington County. Teague stated a new Municipal Separate Storm Sewer System permit is required for participating municipalities starting on August 1, 2024. She then presented a slideshow which summarized the MS4 program and its controlling legislation, the National Pollutant Discharge Elimination System (NPDES). Teague also summarized how stormwater permits are reviewed by the state, noting that each of the 20 MS4 programs permitted in the region have worked together in partnership with the extension and the RPC to meet the relevant stormwater permitting requirements for almost 20 years.

Chair Patsy Christie and Tim Conklin thanked Teague for their ongoing efforts in the region, stating Northwest Arkansas could not be in the position it is in today without the help of her and her team at the Cooperative Extension.

Chair Patsy Christie asked whether there were any other questions or comments and there were none.

(6) PROJECT AND OTHER UPDATES

A. NWARPC FUNDING PROGRAMS (STBGP-A/TAP/CRP) – Project Development & Obligation Plan

Chair Patsy Christie introduced the item and Nicole Gibbs shared the current FFY 2024 obligation plan scenario and noted the importance of jurisdictions progressing their federal aid projects. She said ARDOT staff are working through development of all new project agreements for recently awarded projects.

Tim Conklin said that some projects need to provide additional documentation of progress to ARDOT soon, to avoid any complications with funds reimbursement, and that ARDOT or NWARPC staff may reach out to cities soon for clarification on project timelines, specifically if a project is eligible for earlier funding obligation than previously anticipated. Conklin mentioned that it is always a good idea to reference the ARDOT Local Public Agency (LPA) Manual before taking major steps to ensure that your project funding can be reimbursed in the future. Gibbs shared the images below and asked members to share any updates to the projects shown with NWARPC staff. She explained the dark orange represents projects that have already been obligated, and light orange indicates projects anticipated to obligate this federal fiscal year.

B. 2050 Metropolitan Transportation Plan (MTP)

Chair Patsy Christie introduced the item and Tim Reavis provided the committee with an overview of recent progress made on the update to the MTP, carried out every five years. Reavis said that NWARPC is now under contract with consultant WSP which will assist in developing two key

components of the MTP: an update to the Travel Demand Model (TDM) and conducting a Transit Alternatives Study (TAS). Reavis outlined the purpose and functions of the Travel Demand Model and mentioned that this update will include three different land use scenarios, showing the function of our regional transportation network in each scenario of future growth. He said that the project has been kicked off, and that the consultant is now gathering data and meeting with project stakeholders. He said these model updates will be done using 2050 population projections, and the models will show how population growth can be allocated across the cities of NWA. The TDM & TAS updates will be incorporated into the 2050 MTP which is required to be adopted by the policy committee by March 2026.

Reavis also mentioned that the RPC members will have a 1-year subscription to access the Replica online data platform. He said this is a tool which WSP and the RPC staff will use to develop the MTP, and he hopes that our members will find it useful to supplement their own planning efforts in 2025.

C. Enhancing Equitable Transit Connections Project Update (FTA-AoPP)

Tim Reavis shared that there are two active bus stop related projects being carried out by NWARPC. The first is the Enhancing Equitable Transit Connections Project. This project came about when the Federal Transit Administration (FTA) awarded NWARPC \$180,000 for engineering activities to be applied to area bus stop improvements, including shelters, benches, sidewalk gaps, bike parking etc. He provided an update on this grant program and stated that procurement is now complete, and that NWARPC has selected consultant Olsson to carry out the engineering work. He said that the Walton Family Foundation is offering a one-to-one local government match to supplement this work, up to \$200,000. He encouraged interested communities to participate and apply for this funding for transit stops while it is available.

Reavis also provided an update on the Razorback Transit Bus Stop Enhancements Plan, stating that the Selection Committee has met and chosen consultant Toole Design for this work. He said NWARPC has signed a contract with the firm and Toole staff will be working to inventory Razorback stops and carry out this project through February 2025. Reavis stated that this grant seeks to create a comprehensive inventory of existing bus stops, evaluate the feasibility of improvements, and then draft a plan with recommendations to implement chosen stop improvements for the Razorback Transit system.

Reavis concluded by mentioning the ongoing consultant selection process for the Razorback Greenway Corridor Plan. He said NWARPC was invited to apply for a Walton Family Foundation Design Excellence Planning Grant for the project. He said staff and the selection committee is reviewing the language of the Request for Proposals (RFP) for the program and is conducting interviews of five firm. He said a short list of three firms will be selected to submit project proposals.

D. NWA Vision Zero Safety Action Plan, Phase 2 Update (USDOT-SS4A)

Luke Aitken explained the commission is currently working with consultant Toole design to carry out phase 2 of the Safety Action Plan, to include:

- Regional Complete Streets Design Guide
- 5 Individual Community Safety Action Plans
- 2 Systemic Safety Webinars
- 2 Safety Demonstration Projects
- Communications and Outreach Tools

Aitken stated that progress is being made with Toole Design, with the second Complete Streets Design Guide workshop meeting held recently, and the next, third and final workshop meeting coming up in early October. He recapped takeaways from the second working session which focused on Context Sensitive Street Design. He stated that a safety demonstration project will also be held with Toole design in early October in Bentonville with the Bentonville Fire Department and other regional emergency services staff and said invites will be sent out for that demonstration in September. He also mentioned that the FY2024 Safe Streets and Roads for All (SS4A) application is still open, with the final planning and demonstration grant deadline being August 29, 2024.

E. NWA Energy & Environment Innovation (EEI) Plan (EPA-CPRG)

Tim Conklin said progress is being made by staff and planning partners toward beginning the implementation work, utilizing the \$36.25 million in awarded funds from the EPA CPRG program. Conklin started by congratulating and thanking staff and project partners across the state (our own staff, ADEE staff, WCRC and Fayetteville Sustainability staff, and City of Fort Smith staff and Metroplan staff) and explained how much cross-agency collaboration was required to make this award possible. He said this grant award is unprecedented for the region and state, and he is excited to see the funding bring 18 different projects to life across NWA.

Conklin provided a timeline of the work leading up to the application for the \$99.9 million CPRG Implementation Grant award. He said this funding will help implement a variety of projects in the state of Arkansas and the NWA region, and that the work in NWA will focus on implementing our NWARPC Open Space Plan and NWARPC Bike and Pedestrian Master Plan. Conklin said the coalition of three metro regions in the state – NWA, Ft. Smith, and Little Rock – all working together, made the application much more competitive at the national level. Conklin outlined the 18 projects funded by the NWA portion of the Implementation Grant and the “NWA Green Network” focus, which preserves and restores the region’s natural cores and corridors and links them to the regions safe and connected Active Transportation network. He concluded his remarks stating that these 18 key projects will help connect communities to natural spaces, jobs, education, and essential services while incentivizing a mode shift toward cycling to reduce environmental impacts of transportation.

Nicole Gibbs explained that Phase 2 of the planning work is underway with the development of the NWA Comprehensive Action Plan (CAP). She said the consultant, Olsson, is working with NWARPC staff to create a more comprehensive deliverable for the CPRG Planning Grant, building upon the measures outlined in the Priority Action Plan (PAP), by using funding suballocated to NWARPC by Arkansas Department of Energy and Environment (ADEE). She said the PAP identifies top priority measures for the region, which the CAP will expand upon, outlining actionable steps, toward regional implementation of the new and existing priority actions. She said the plan will support future planning and funding opportunities for the NWA MSA, related to environmental quality and emissions reduction. Gibbs stated the deadline for the CAP supplement to ADEE is February 28, 2025 and that staff will be doing extensive public outreach from now through October. The final CAP will be considered for adoption by the RPC/Policy Committee in Spring 2025. She emphasized that both documents will serve as components of the 2050 Metropolitan Transportation Plan (MTP) update.

F. NWA Mobility - Strategic Communications Plan

Nicole Gibbs introduced the item and stated that NWARPC contracted with the consulting firm mhp.si, chosen by the selection committee. The plan’s purpose is to advance the regional conversation around mobility to respond to the rapid growth of the NWA region. In addition to the 12-month strategic communications plan, deliverables will include a messaging guide and scientific

public opinion survey. She said this plan will help to build awareness of the planning work being done in the region and support the work of regional municipalities to promote responsible growth by highlighting our focus and expertise around transportation planning. She mentioned that focus groups have already been conducted, providing the first level of insights from this project, showing overall themes of the public's impressions around transportation planning taking place in the NWA region. She said the scientific public opinion survey is underway, with results expected to be presented to staff by October. She stated that NWARPC staff's ongoing work to update the Public Participation Plan will also be informed by the best practices recommended in this communications plan.

G. Other Grant Opportunity Updates

Tim Conklin provided information on the ongoing grant opportunities being pushed out by USDOT. He showed the new Notices of Funding Opportunities (NOFOs) that have been announced by US Department of Transportation (USDOT) from the Key Notices of Funding Opportunity Webpage (<https://www.transportation.gov/bipartisan-infrastructure-law/key-notices-funding-opportunity>). He also highlighted the Strengthening Mobility and Revolutionizing Transportation (SMART) Grants Program, which aims to support demonstration projects that enhance transportation safety and efficiency through smart technology and information systems. Conklin stated that Ozark Regional Transit will be applying for \$1.5 Million of federal funding from this program for the NWA Dynamic Signal Priority Project, which will allow ORT and NWA communities to evaluate Transit Signal Priority.

Conklin also provided an update on the recently opened Reconnecting Communities Pilot (RCP) Program and encouraged communities to apply by September 30, 2024 and highlighted the open Community Change Grants program through the EPA, and the Reconnecting Communities Pilot Program offered by USDOT.

Conklin also provided an update on the grants being pursued for Highway 112, including ARDOT TAP, ATIIP, SS4A, and RAISE programs, to fund the preferred bicycle accommodation of a 12-foot sidepath along the entirety of the Highway 112 project. He also mentioned that the staff has applied for a \$160 million MPDG grant for US 612, with support from the NWA Council on the required Benefit Cost Analysis (BCA). These applications total \$250 million in USDOT grant funding which has been applied for this year by staff.

Tim Conklin congratulated the City of Siloam Springs on their \$11.6 million RAISE Grant award to improve E Main St as a Complete Street, and also congratulated ARDOT on their \$25 million RAISE Grant award from the USDOT, funding an extension of I-49 south from Alma, Arkansas.

(7) COMMITTEE AND GROUP UPDATES

A. Active Transportation Committee

Luke Aitken said the ACT Committee will meet on September 19, 2024 to discuss new grant opportunities, subcommittee reformation for the NWA regional bike and pedestrian plan update, and recent bike and pedestrian project developments in the region, they last met on July 18, 2024.

B. NWA Open Space Coalition

Aitken said the group's July meeting was held on July 10, 2024 in Greenland, to visit the site of a future city park along the White River. Aitken said the meeting had a great turnout, generated positive momentum for this project, and raised awareness of other regional efforts to preserve the White River. He said the next meeting will be held September 11, 2024 at Lake Bella Vista in Bentonville.
